• To be used by Non-UK Nationals who are applying for paid work can.

Minimum of 3 documents to be provided in all cases. Collectively documents should prove identity, right to work in the UK, name, address and date of birth.

- At least one document should be provided from 1a Primary Documents to support permanent or temporary right to work in the UK. If applicant is unable to provide this documentation, they can't submit a DBS check. This is because the right to work in the UK can't be established. No other route for paid personnel can be used.
- Further two documents from supportive documents 1b, 2a or 2 b should be supplied. **Please note** that a passport or biometric residence permit can only be used as a supportive document if it has not already been used as a primary document.
